

Big changes for merchants...








#### What's Different?

- Merchants are required to perform risk assessments of their cardholder data environment.
- Documented policies and procedures.
- Security awareness training.
- Right now it's reccomended, but on March 31st it will be mandated?



#### HOW DOES ENDSIGHT HELP?

- Properly scope your CDE to limit your compliance exposure.
- Conduct targeted risk assessments of the scoped environment.
- Identify and recommend remediation of deficient controls.
- Draft formal PCI procedures.
- Create the required security policies.


